

## "Henkel Canada Corporation GE Sealants Canada Pro Contest" Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING. MANY WILL ENTER, FEW WILL WIN.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

All submissions must be uploaded and received no later than 11:59 PM (EST) on September 30, 2025. Administrator's computer is the official time-keeping device for the Contest.
- 5. HOW TO ENTER: The Contest can only be entered by scanning the QR code on marketing materials at retailers or through the GE website by applying through the form provided at <a href="https://gesealants.ca/procontest/">https://gesealants.ca/procontest/</a>. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Henkel and/or Administrator. There are no alternative methods of entry. Charges that may be incurred to enter (e.g., text message and/or data rates) are the sole responsibility of Entrant.

Henkel and Administrator are not responsible for incomplete, lost, late, damaged, illegible or misdirected entries or for any technical problems, malfunctions of any telephone lines, computer systems, servers, providers, hardware/ software, lost or unavailable network connections or failed, incomplete, garbled or delayed computer transmission or any combination thereof. **TOTAL ESTIMATED VALUE FOR THE CONTEST:** US \$5,840 CAD. Actual/appraised value may differ at time of prize award. No cash or other prize substitution may be permitted except at Henkel's sole discretion. Prizes are non-transferable. Any and all prize-related expenses, including, without limitation, any and all federal, state, provincial, and/or local taxes shall be the sole responsibility of each prize winner (each, a "Winner" or "prize winner"). No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by the Winner is permitted.

7. ODDS: The odds of winning depend on the number of eligible entries received.

## 8. SELECTION OF POTENTIAL WINNERS; NOTICE TO POTENTIAL WINNERS; VERIFICATION OF WINNERS:

- \$5,000 cash prize: once the Contest Entry Period is complete on 11:59 PM (EST) on September 30, 2025, one potential winner will be selected at random on or by October 10, 2025, and will be notified promptly thereafter.
- GE Sample Kits: the Contest period for GE Sealants Sealed for Good Kits will close at 11:59 PM (EST) on the last day of each month during the months of September 2024 through August 2025. Potential winners will be selected at random at 1PM ET on the 11th day of the following month except the month of December, May and September which will be drawn on the 10th day of the following month. The random drawing will be conducted by the Contest Administrator in Rochester, New York. Winners will be notified promptly thereafter.

PRIZE LIMIT: Entrants cannot in any event win more than one each of a GE Sealants Sealed for Good Kit prize.

All results of the selection are final and binding, subject to these Official Rules. It is expected that any potential winner will be contacted via email, using the email address/information provided by Entrant. (Henkel and Administrator may, in their sole discretion, attempt to contact a potential Winner by other means using the information provided by Entrant.) GOVERNING LAW/FORUM/DISPUTE RESOLUTION: The construction, validity, interpretation and enforceability of these Official Rules, and the rights and obligations of entrant and Henkel (and Administrator) in connection with the Contest, shall be governed by, and construed in accordance with the laws of the provincial and federal courts in Mississauga, Ontario, without giving effect to any choice of law or conflict of laws rules or provisions. Any legal claims arising out of or relating to the Contest or these Official Rules must be brought in the federal or state courts located in the provincial and federal courts in Mississauga, Ontario and shall NOT be brought as part of a class action. You further agree to the jurisdiction of such courts and that, in any claim/cause of action, your recovery will be limited to actual costs of participating in the Contest (if any) and that all other damages (including compensatory, consequential, incidental, and punitive damages) are expressly waived. DISPUTES: The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the provincial and federal courts in Mississauga, Ontario and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Contest shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. If an in-person hearing is required, then it will take place in Mississauga, Ontario. The federal or provincial law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is

unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in Mississauga, Ontario. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.

For Quebec residents: Any litigation respecting the conduct or organization of this Contest may be submitted to the Régie des alcools, des courses et des jeux du Quebec for a ruling. Any litigation respecting the awarding of a prize may be submitted to the board only for the purpose of helping the parties reach a settlement.
